### **What is a webinar?**

A webinar is an interactive online seminar held over the Internet at a specific time. University members of HSRW can participate in the webinar for free. Participants need a PC, tablet, or smartphone that can access the Internet, and can participate in the webinar from any location they choose. The webinars are hosted by expert speakers

and are designed in such a way that there is enough room for questions in addition to presentations.

## **2.2 Childcare options in Kleve und Kamp-Lintfort**

### **Daycare (Kitas)**

From their first birthday to the first grade, children in Germany have a legal entitlement to a spot in a day-care facility or to a home day-care service. Children younger than one year are entitled to day-care when their parents or legal guardians resume working or are currently enrolled students (see Volume VIII, German Social Code, Section 24 for more information).

Both Kleve and Kamp-Lintfort offer a number of day-care facilities run by different organisations. Policies for opening hours and distribution of spots vary, thus specific Kitas should be contacted individually for more information:

### **Home day-care services**

Home day-care services, for example with licensed child minders (*Tagesmutter* or *Tagesvater*), are also available in Germany for children up to three years of age. Home day-care services come in the following arrangements (subject to local availability):

- childcare at home,
- childcare with a child minder and up to four children, and
- childcare with a team of up to three child minders and up to nine children in suitable external facilities.

Child minders are much more than babysitters, they also promote the individual social and mental development of the children they care for. They plan educational activities,

support the parenting process, and help parents pursue a healthy work-life-study balance.

The main advantages of child minders over Kitas are:

- small groups,
- family-like environment and structure,
- tailored to parents' specific needs,
- usually close to home and
- flexible scheduling.

Children enrolled in day-care facilities or schools are also eligible for supplementary childcare through a child minder as well.

Fees are also calculated according to parents' income and are thus comparable to those of a Kita.

## 4. Maternity Protection

---

### **Information on the Maternity Protection Act of the HSRW**

As of 1 January 2018, Germany's Maternity Protection Act (Mutterschutzgesetz, MuSchuG) applies to pregnant students as well, granting special legal protections during pregnancy and nursing periods. These include, for example, a legally protected maternity leave before and after your pregnancy (generally 6 weeks prior to birth and 8 weeks afterwards), as well as a right to alternative arrangements for courses and/or lectures held during this time.

### **Disclosing your pregnancy to HSRW**

The position of pregnant and breastfeeding students has been significantly enhanced by the law. For example, there is now an obligation to register and report pregnant students who want to make use of the protection and the associated regulations. It is also required to conclude an assessment of study programs and study procedures for possible hazards, analogously to the assessment of workplaces for possible hazards to pregnant women and their unborn children, which is independent of the occasion.

In order to claim and assert your legal rights, you must officially disclose your pregnancy and/or nursing period to HSRW (pursuant to § 15 MuSchuG). We cannot obligate you to do so: it is ultimately your decision. Naturally, we recommend you do contact us so that we can help you better understand your legal rights as a mother-to-be and avoid potential health risks related to your studies as early as possible. To disclose a pregnancy, please contact the Study Guide for your faculty. The contact information can be found [here](#).

### **Risk assessment and alternative arrangements**

Some of your modules and study course related events may pose potential health risks to the students or the child, for example labs in technical or scientific degree programs or activities involving young children in the framework of the study program Early Childhood Education B.A.. The university is thus obliged to carry out a risk assessment for the relevant study programs with regard to pregnancy / breastfeeding and to act accordingly (§10 MuSchuG).

The university therefore offers the opportunity for an individual consultation about relevant regulations, counselling, and support services within and outside the university and plans the suitable steps together with the mother. In the case of a discovered pregnancy, you can contact the study guide responsible for the faculty.

Their contact details (as well as further information on maternity protection) can be found on the [homepage of the student guides](#).

Maternity protection includes not only the entitlement to protection periods before and after childbirth (6 and 8 weeks respectively), but also the possibility of compensation for disadvantages if examinations take place during this period. Section 6 (4) of the RPOs stipulates that examination procedures must allow for the use of protection periods according to the Maternity Protection Act and the Parental Allowance and Parental Leave Act, as well as for periods of absence due to the care of persons according to Section 64 (2 a) HG NRW. If a time adjustment of procedures is necessary, an application by the candidate to the examination board is usually required.

It is generally advisable to talk to the examiners in advance and to find out about possible individual solutions or alternative study/ examination arrangements. However, there is no obligation to offer alternative arrangements (especially for examinations). In any case, however, the triangle between the student, the examination board and the examiner will strive to find a feasible solution that is as favorable as possible for all parties involved.

## **Funding options**

### **Federal Foundation – Mother and Child** – *Bundesstiftung Mutter und Kind*

The [Federal Foundation - Mother and Child](#) provides emergency financial support to pregnant women, acting as an additional safety net in cases where statutory financial assistance is insufficient or otherwise unavailable. The amount and duration are generally determined by the individual financial need of the expectant mother. As a general rule, the Foundation grants subsidies on a subordinate basis. Thus, potential applicants should first apply for all financial support options provided by the German government. The Foundation can then supplement the benefits granted according to its assessment.

### **Right to maternity protection to compensate for financial disadvantages**

The [Maternity Protection Act](#) (Mutterschutzgesetz, MuSchG) applies to all (expectant) mothers who are in an employment contract. This also implies home workers, domestic workers, marginally employed persons, female trainees and, under certain conditions, female pupils and students.

The aim of maternity protection law is to ensure the best possible health protection for pregnant and breastfeeding women. Women should not suffer disadvantages in their working lives because of pregnancy and breastfeeding, nor should a woman's self-determined decision about her employment be violated. This will improve women's opportunities and strengthen their rights to continue working during pregnancy and breastfeeding without compromising their health and that of their child.

In order to protect women from financial disadvantages during this period, the Maternity Protection Act regulates various maternity benefits:

### **Maternity benefits** - *Mutterschaftsgeld*

Many female students work part-time during their studies and as a result the provisions of the Maternity Protection Act (Mutterschutzgesetz) also apply to them before and after birth.

Not all female students are eligible for maternity benefits, as it depends on an existing employment relationship that is interrupted by the statutory prenatal protection period in Germany. In addition, female students must also be enrolled with a public health care insurance provider. The type of health insurance is also an important consideration.

Female students with compulsory or voluntary health insurance through a public health insurance provider will receive maternity benefits directly from their insurance provider. The amount is based on the student's average net salary for the previous three calendar months before the statutory protection period took effect. Applications

must be filed directly with the health insurance provider.

Female students with family health insurance or private health insurance are eligible for maternity benefits from the German Federal Insurance Office (Bundesversicherungsamt) if they worked at a company or as a freelancer before the statutory protection period or their employment contract was lawfully terminated by their employer during pregnancy.

### **Employer's supplement to maternity pay during maternity protection periods**

You are entitled to the employer's supplement to maternity benefit if your average net wage per day is higher than 13 euros. This means from a monthly net wage of 390 euros.

### **Payment of wages in case of employment prohibitions outside the maternity protection periods** (so-called maternity protection wages)

You receive maternity protection pay if you are not allowed to work before the start and after the end of the maternity protection periods due to a prohibition of employment, for example due to a medical prohibition of employment.

Maternity protection pay is the average pay of the last three calendar months prior to the start of pregnancy. If the employment relationship does not begin until after the onset of pregnancy, the average remuneration shall be calculated from the remuneration of the first three months of employment. Maternity protection pay is considered a normal wage and you must pay taxes and social security contributions.

In order to receive your maternity protection pay, you must submit a certificate of the individual employment prohibition to your employer as soon as possible.

### **Financial Support for Single Parents (BMFSFJ)**

#### **The Relief Allowance – Entlastungsbetrag**

Single parents have to bear higher financial burdens due to more expensive household management. This is where [the tax relief allowance](#) for single parents can help. A variety of family benefits, for example child benefit, advance maintenance payments or child supplement, help to improve the financial situation for single parents and their children. Other social benefits - for example housing benefit or basic security benefits - also provide special support for single parents.

The relief contribution is currently 4008 euros per year (as of 2022). If there are several children, the relief amount increases by 240 euros per child from the second child onwards.

#### **Maintenance Advances – Unterhaltsvorschuss**

[Maintenance Advances](#) are available to children who live with a single parent and get no or little regular support from the other parent. It is applied for in writing at the maintenance advance office (usually at the competent youth welfare office). There is



no income limit for the single parent. A court maintenance judgment against the other parent is not required. If the other parent is fully or partially productive, the state will claim the amount of the child support paid.

Advance maintenance payments are granted without a time limit. The payment ends at the latest when your child turns 18. The amount of the advance maintenance payment depends on the age of the children and since 1 January 2022 amounts to the following per month ([BMFSFJ - Unterhaltsvorschuss](#)):

- 177 euros/month for children from 0 to 5 years,
- 236 euros/month for children from 6 to 11 years,
- 314 euros/month for children from 12 to 17 years.

### **Maintenance**

Maintenance is what one person provides to meet the living necessities of another person. Maintenance can be provided, for example, in the form of money, property, but also education, care, nursing and personal attention. Who pays what for maintenance is particularly important when parents separate. Maintenance is provided, for example, for [children](#), [divorced persons](#), [separated persons](#) and [unmarried parents](#).

### **Tax Relieve**

The website of the Federal Ministry for Family Affairs, Senior Citizens, Women and Youth provides information on the exemption amount for children of single parents.

### **Citizen's Benefit for Single Parents**

If a parent is separated or a single parent and receive Citizen's Benefit, they can receive additional benefits for single parents. The amount of the additional benefit depends on the number and age of the children.

### **Social assistance**

If a parent is separated and raises a child or a single parent and does not receive Citizen's Benefit, they can get social assistance. In addition, they will receive supplementary benefits depending on the age and number of their children (single-parent supplementary benefits).

Regulated by law is only the case that a single parent is responsible for the care and upbringing of the child without the involvement of the second parent. In this case, they alone are entitled to the statutory amount of additional benefits.

If the second parent participates proportionately, the additional benefit for single parents is to be distributed by individual decision. In view of the very small number of

children and single parents entitled to benefits under SGB XII compared to SGB II, this allows for flexible solutions.

Single parents can especially claim the **Parental Allowance** and the **Child Allowance**. Further in-depth information can be gathered from chapter 6 "[Financial Support](#)".

## 6. Financial Support

---

Raising a child while earning a degree is not easy. One of the biggest challenges is finding a way to finance studies and family budget. Students often live on tight budgets as it is – and that is before factoring in the cost of childcare.

Fortunately, students in Germany are generally eligible for a number of financial support options, whether separately or in combination, that can ease the financial burdens of raising a child.

The following section provide an overview of the main child benefits available in Germany. The amounts of these benefits generally change over time, so it is important to look into the rates for the current calendar year. Also, note that not all students in Germany are eligible to apply.

### **Federal student loans – BAföG**

**Important note:** Students with a residence permit for study purposes (Section 16 AufenthG) are ineligible for BAföG!

Students with children or parents-to-be who are currently receiving federal student loans (BAföG) can apply for an additional [childcare allowance](#). This allowance is intended to help parents pay for the costs associated with childcare so that they can return to their studies. Students are eligible for this allowance of 160 euros per month (per child) for as long as they continue to receive BAföG and, at the same time, share a household with at least one of their (own or adopted) children under 14 years of age (§ 14b BAföG).

The childcare allowance does not need to be paid back at the end of the loan period. However, if the student lives in a household with their partner and both of them are currently receiving BAföG, note that only one is eligible to receive the childcare allowance.

Beyond the childcare allowance, student parents receiving BAföG can generally extend their loan period for a reasonable amount of time to compensate for the delays caused by having and/or raising a child. As a result, additional loan payments due to childcare are treated as a bonus, meaning they do not come with repayment obligations.

More information about the childcare allowance and other special provisions affecting students with children or parents-to-be (interruptions to study progress, examinations etc.), can be found on the websites of the [Federal Ministry of Education and Research](#) (in German) and the [Studierendenwerk Düsseldorf](#) (in German).

### **Parental allowance – *Elterngeld***

Parental allowance is a form of income compensation for lost earnings. Parents who take time off from work following the birth of their child are eligible to receive this allowance for up to 14 months (14 months if both parents take parental leave, one parent can take a maximum of 12 months), which amounts generally between 65% and 67%, in exceptional cases up to 100% of the parent's average monthly (net) salary prior to the birth (up to a maximum of 1,800 €). Students with little to no income are usually eligible for the minimum amount of 300 € per month.

Parental allowance can be combined with other social benefits as well. More information about eligibility, sibling bonuses, the new parental allowance plus programme (*ElterngeldPlus*), deductions and more, can be found via [Familienwegweiser](#) (in German).

### **Child benefits – *Kindergeld***

Parents living in Germany and with unrestricted tax liability are entitled to child benefits in the form of a tax break (see Section 62 ff. of the Income Tax Act [[Einkommenssteuergesetz](#)]).

In all other cases, child benefits are a non-income-related allowance that is tiered according to the number of children. Current rates are (as of January 2021):

- for the first and second child: 219 euros a month,
- for the third child: 225 euros a month,
- for the fourth child and every additional child: 250 euros a month.

Parents are eligible to receive child benefits:

- for every child until their 18<sup>th</sup> birthday,
- for children in an apprenticeship or vocational training programme until their 25<sup>th</sup> birthday,
- for children unable to find employment: until their 21<sup>st</sup> birthday.

The second eligibility scenario above also applies to children who are unable to start or continue an apprenticeship or vocational training due to a lack of available spots.

If the child has successfully completed a first apprenticeship/vocational training or degree, the parent is still eligible for child benefits if they work an average of 20 hours or less per week.

Child benefits are transferred monthly directly to the child's parent or legal guardian's bank account. Parents raising a child together can decide who should receive the benefit.

Parents who live abroad and have limited tax liability in Germany according to the Income Tax Act can, in some circumstances, also receive the child benefit.

The children for whom child benefits are being paid must reside in Germany or a member state of the European Union.

Orphans or children who have been abandoned by their parents are eligible to apply for the child benefit themselves.

In most cases, child benefits are paid by the Department of Child and Family Services (*Familienkasse*) of the responsible employment agency (*Agentur für Arbeit*).

The [Federal Ministry for Family Affairs, Senior Citizens, Women and Youth](#) can be consulted for more information (in English).

### **Child allowance – *Kinderzuschlag***

Both single parents and couples are eligible for a supplementary child benefit for each child living in their household who is unmarried and younger than 25 years of age if

- child benefits are already being paid for the child,
- the parents' monthly income exceeds the minimum threshold,
- the parents' combined income and assets do not exceed the maximum threshold, and
- the child supplement would elevate the family's income such that they become ineligible for social benefits (*Citizen's Benefit* or *Sozialgeld*).

The minimum threshold is 900 € for couples and 600 € for single parents. Parents are only eligible for the child supplement if their monthly income in money or monetary equivalents (e.g. gross income, *ALG I*, sick pay etc.) exceed the appropriate minimum threshold.

At the same time, net income and assets may not exceed the appropriate maximum threshold. This threshold is calculated by adding the figure for the parents' basic needs (according to *Citizen's Benefit*) plus a percentage of living costs plus the total potential child supplement to be paid.

An entitlement to the child supplement nullifies an entitlement to *Citizen's Benefit* /social benefits and vice-versa.

The amount of child supplement per child varies and is calculated according to the income and assets of the parents and, where applicable, children. As of 1 January 2022, child supplement amounts to a maximum of 449 € per month per child, which is transferred together with the child benefit every month.

To apply for child supplement, please contact the [Bundesagentur für Arbeit](#) that is responsible for all applications and processing. You will be informed about the decision of your application in writing.

Funding options for mothers and mothers-to-be are listed in chapter 4 “[Maternity Protection](#)”.

### **Citizen’s Benefit – *Bürgergeld***

Students are generally ineligible to receive Citizen’s Benefit in Germany because of *BAföG*, but there are some exceptions. For example, students who live with their parents can, in some cases (which are defined by Section 7 (6) No. 2 of Volume 2 of the German Social Code [*SGB II*]), apply for additional financial assistance on top of their monthly *BAföG* assistance.

The [Studierendenwerke](#) offer individual consultation.

In cases of particular need or hardship, students can also receive additional financial support through the *Citizen’s Benefit* programme – but only in the form of a loan (refer to Section 27 (4) *SGB II*). Students can assert claims for additional assistance if they are raising children and as a result cannot work part-time during their studies. In this case, even students receiving *BAföG* are eligible for supplementary assistance. As always, eligibility decisions ultimately occur on a case-by-case basis.

Students expecting or raising children frequently require additional assistance above and beyond *BAföG*. These additional needs can be covered by additional subsidies (see Section 27 (2) *SGB II*). Mothers-to-be, for example, are potentially eligible for additional subsidies for clothing and essentials.

Students taking a leave of absence for pregnancy or childcare purposes are also eligible for *Citizen’s Benefit*. During this time, students are prohibited from earning credits towards their degree.

Also, note that while student parents may be ineligible for *Citizen’s Benefit*, minors under 15 years of age may in some cases be entitled to social benefits according to *SGB II*.

### **Educational and inclusiveness assistance**

Parents and legal guardians receiving the child supplement can also receive additional assistance to enable their children to participate in educational and inclusiveness activities.

In particular, this assistance covers the following:

- all-day or multiple-day excursions at schools or Kitas,
- essential school materials,
- enabling transportation to school,
- appropriate learning support/tutoring,
- school or Kita lunches,

- social or cultural activities in the community.

The [educational and inclusiveness assistance](#) are to be applied for at the competent municipal office.

### **Student loans from the Studierendenwerk Düsseldorf**

The Studierendenwerk Düsseldorf offers three student loan possibilities: the *Daka* loan, the *Bildungskredit* and the *KfW-Studienkredit*.

*Daka*, an abbreviation from the German “[Darlehenskasse der Studierendenwerke e.V.](#)” (in German), is a loan office of the Studierendenwerk Düsseldorf that offers students a way to finance their studies without juggling a full or part-time job at the same time.

Students can apply for an interest-free loan of up to 12,000 euros and variable monthly payment instalments of up to 1,000 euros. Funding is possible at any stage of the studies. The funding period depends on the needs of the student.

The [KfW-Studienkredit](#) (in German) is another way for students to finance their studies. Students between the age of 18 and 44 (at the time of beginning their current degree) who are pursuing a first or second undergraduate degree, a graduate degree or a doctoral degree are eligible to apply. Note that eligible students must be enrolled as full or part-time students at a public university located in Germany.

The German Federal Government also offers both students and young people in later phases of an apprenticeship or vocational training the possibility of a low-interest loan, the so-called [Bildungskredit](#) (in German). The goal here is to provide an additional low-risk financing opportunity to students and apprentices so that they can focus on completing their education or training. Funding is provided irrespective of the assets and income of the applicants and their parents.

Up to 7,200 euros can be granted within one training period.

### **Scholarships**

Scholarships in Germany are often awarded by foundations that are affiliated with political parties, religious or secular organisations. These scholarships are awarded according to specific criteria, usually personal (sex; ethnic or social background) or academic (performance, extracurricular engagement) in nature. Some foundations offer special scholarships exclusively to female students or single parents. To search for available scholarships for students in Germany, please visit [MyStipendium](#) (in German).

### **Federal Foundation - Mother and Child – *Bundesstiftung Mutter und Kind***

The Federal Foundation - Mother and Child (in German) provides emergency financial support to pregnant women, acting as an additional safety net in cases where statutory financial assistance is insufficient or otherwise unavailable. As a result, potential applicants should first apply for all financial support options provided by the German government.

When an application is received, the foundation evaluates the applicant's income situation and decides on a case-by-case basis to grant additional financial support. Other eligibility requirements include a permanent residence in Germany and a compulsory consultation with a family planning organisation. There is no legal entitlement to the foundation's financial support.

This financial support does not conflict with other available social benefits such as Citizen's Benefit etc.

### **Information by the Studierendenwerk Düsseldorf for international students with children**

The advising services of the Studierendenwerk Düsseldorf provide initial information for student parents, particularly with regard to available financial assistance. When they cannot help directly, they will refer to the appropriate person/organisation.

These advising services are particularly important for students from a non-EU country, as they teach more about the rights in Germany and whether the eligibility for certain forms of assistance is restricted. As a rule: always consult with staff at the local immigration office before filing any applications for financial assistance!

For childcare information, the partner organization PME Familienservice can also help with certain applications.

For advice related to a specific study progress, contact either the Study Guide of their respective faculty or, if applicable, the respective study course manager.



## 7. Degree Progress and Exams

---

### **Studying full-time as a parent**

Rhine-Waal University of Applied Sciences offers bachelor's degrees in seven semesters of full-time study and master's degrees in three. Though difficult, it is definitely possible for parents to manage a full-time student workload.

Lectures, seminars and practicals are generally held between 8 a.m. and 4 p.m. All-day childcare (whether through a kindergarten, daycare or other recognised organisation) generally affords parents enough flexibility to attend all courses that are held during the day.

Sometimes courses may take place in the early evening (up to 6 p.m. or later) which will often require additional childcare arrangements. The partner organisation PME Family Service can support student's search for supplementary childcare for these kinds of cases (see [section 2](#) above).

In many cases, attendance is not mandatory (excepting certain seminars, projects or practicals). While this affords a certain additional flexibility, students are responsible to catch up on any missed content and course work if they do not want to jeopardise their studies or performance. Fortunately, most professors and lecturers upload course documents, files and learning materials to Moodle for easy access at home. Students are additionally recommended to speak with their professors and lecturers in advance so that they understand that the student's absences are related to childcare obligations. An open dialogue can potentially lead to individual solutions that can help students to balance their obligations as a both, parent and student.

Sometimes it is unavoidable for students to bring their child to campus, whether for important group work or to use campus resources and facilities in the evening hours. In this case, students (and their group) can book the campus parent-child room or temporarily borrow a portable toy box (see [chapter 8](#)). On Campus Kleve (17 EG 003 and 006) there are two mobile boxes of toys available free of charge and on Campus Kamp-Lintfort (02 EG 505 Student Service Point) there is one available for borrowing.

Finally, exams are usually offered at family-friendly times during the day. In some cases, however, exams might not finish until 6 p.m. Thus, extra childcare planning may be necessary.

### **Studying part-time**

If a student is currently working at least 20 hours or is self-employed, they are eligible to enrol as a part-time student in certain degree programmes at Rhine-Waal

University of Applied Sciences. As a part-time student, they have more freedom to plan their studies around their individual work schedule and can potentially earn a bachelor's degree in as few as 9 semesters. More information can be obtained from the [Central Student Advisory Service](#) (ZSB).

### **Compulsory exam registration**

The [General Examination Regulations](#) (RPO) which came into effect in 2018, regulates that there are no more compulsory exam registrations. However, students are advised to look into their study course specific Examination Regulation. These regulations can deviate from the regulation as it is the case for example for the faculty of Society and Economics. Nevertheless, in exceptional circumstances, the faculty's examination board should be consulted regarding implementation choices. Exceptional circumstances are also mentioned in course-specific examination regulations, which might include child care and rearing. For example, in the event of the care and raising of minors, it would be feasible to debate the potential of granting an application for an exemption from compulsory registration.

### **Thesis**

Section 25 and 23 of the RPO permits the head of your Examination Board to extend thesis deadlines if justified and requested in writing before the end of the original deadline. Justified reasons for an extension include, for example, periods of time in which you cared for an ill child. Requests usually need appropriate proof (i.e. a doctor's note) and are always decided on a case-by-case basis.

### **Sick on exam day**

According to Section 13(2) of the RPO, students who miss an examination because of illness can submit a doctor's note (in some cases from a doctor of your Examination Board's choosing). If the Examination Board excuses the absence, the examination attempt is automatically nullified.

The Examination Board can also recognise absences which were caused by an ill child and lack of alternative childcare arrangements. However, as with deadline extensions, students must submit verifiable proof (i.e. doctor's note) and decisions are made on a case-by-case basis. As always, it is important that students notify their instructor as well as the Examination Service and their Examination Board as soon as possible after an absence.

### **Semester of leave**

Students at Rhine-Waal University of Applied Sciences are entitled to semesters of leave for important reasons (see Section 9 of the [HSRW Enrolment Regulations](#)). This can be relevant, for example, in order not to extend the standard period of study. Important reasons include pregnancy, the care and upbringing of minor children or the care and support of spouses, life partners, or other close relatives. Note that during a semester of leave you will not be eligible for your BAföG assistance, if applicable.

While students are generally prohibited from earning credits during a semester of leave, by law this restriction does not apply to those providing care to a child or immediate family members.

For protection periods and equivalent benefits during maternity leave, see [Chapter 4](#) (Maternity Protection).

## 8. Family-Friendly Infrastructure at HSRW

---

### **Parent-Child Rooms**

Each campus has a designated parent-child room, which can be used at no charge by all members of the Rhine-Waal University of Applied Sciences. In Kleve, the parent-child room is located in room 17 EG 004, in Kamp-Lintfort in room 04 01 325. Both rooms contain a PC workspace, a child-sized bed, a sofa and a play corner. In order to use the parent-child room, the room must be booked for the desired date. An access is possible via a transponder.

Students may contact the central opportunities representative, the equal opportunities office or decentralized equal opportunities representatives for a reservation of the room. After booking, a transponder for the room can be borrowed on the day of the booked appointment at the locations mentioned below.

#### *In Kleve*

- at the campus supervision (building 04, ground floor)
- at the Dean's Office faculty Life Sciences (12 01 006)
- at the Dean's Office faculty Society and Economics (02 01 008)

#### *and in Kamp-Lintfort*

- in the library (building 01, top floor)
- at the Student Service Point (02, ground floor, 505).

After using the room, the transponder must be returned personally.

Both [campus libraries](#) include individual work rooms ([carrels](#)) which can be booked by student parents and outfitted with an additional child-sized desk and chair upon request. Carrels must be booked at least 24 hours in advance.

### **Student Advisory Service (ZSB)**

The Student Advisory Service has a play area to be used by children while their parents get consultation regarding their studies.

### **Portable toy box**

To make Rhine-Waal University of Applied Sciences an even more family-friendly place of study and work, the Equal Opportunities Team offers students and employees mobile toy boxes.

Due to childcare emergencies, it can happen that students or staff have to bring their child to the university. The mobile boxes of toys help parents and children to make their stay at the university entertaining. They include toys for infants like colouring books and crayons, picture books and reader, puzzles, games or puzzle magazines and can be handed out on an hourly or daily basis.

On Campus Kleve (Building 17, Equal Opportunities) there are two mobile boxes of toys available free of charge and on Campus Kamp-Lintfort (02 EG 505 Student Service Point) students can borrow one.

Students are also provided with the Moodle course “[Familienservice/Studieren mit Kind](#)” that offers a cluster of information regarding different topics. The password for enrolment will be sent upon submitting a request to [familienservice@hochschule-rhein-waal.de](mailto:familienservice@hochschule-rhein-waal.de). All staff members and students with children and/or with caregiving responsibilities to family members are able to find current offers in the Moodle course. Furthermore, the Moodle course holds a forum in order to enable students to exchange their questions, experiences and other concerns.

The family service has created a block on the topic coronavirus and home office with children. University members will find further ideas, information and tips for everyday

life with child during this exceptional situation. Furthermore, information is provided on caring for family members during the Covid 19 pandemic.

### **Childcare options during the exam period**

The Family Service offers (irregular) emergency childcare during the exam periods, which coincide with holiday periods. Students are recommended to look out for the latest information mails from the Family Service.

## 9. Accommodation

---

### **Halls of residence run by the Studierendenwerk Düsseldorf**

The Studierendenwerk Düsseldorf offers affordable housing solutions in both Kleve and Kamp-Lintfort. Many of the flats in these halls of residence accept parents with children as well.

All students at Rhine-Waal University of Applied Sciences are eligible to apply for housing from the Studierendenwerk Düsseldorf. These rooms are in high demand, so students may be put on the waiting list first. Students who are interested in signing up for a room, are required to register online at the homepage of [Studierendenwerk Düsseldorf](#) (in German) as soon as possible.

### **Housing allowance (*Wohngeld*)**

Parents searching for a place to stay need to consider not only their proximity to campus, but also whether there are any nearby *Kitas*, schools or child minders.

Before housing is found, parents should also investigate whether they qualify for a housing allowance through the German government. If so, there are additional important housing criteria to consider (e.g., maximum allowable size of the flat). An initial consultation with the housing allowance office [*Wohngeldstelle*] is strongly advisable.

The housing allowance is an additional financial support available for both renters (whether in flats or single rooms) and for parents who own the house or flat they are living in. General eligibility for housing assistance, as well as the amount the parents are entitled to, depend on three main factors:

- the number of people in the household,
- parents' total combined income,
- the eligible amount of rent/mortgage payments.

Parents' monthly combined income may not fall below or exceed certain threshold amounts. More information can be found [here](#).

House allowance can be approved for up to 12 months and payments begin in the month of filing. Each extension beyond this initial period requires a new application before a certain deadline. For a non-binding eligibility check, please visit [the housing allowance calculator](#) (in German) maintained by the state of NRW.

Generally, if the student is currently receiving social assistance on the basis of *SGB II*, *SGB XII* and *SGB VIII* (such as *Citizen's Benefit*, social or income support), other supplementary income assistance, financial assistance via the *Bundesversorgungsgesetz* or *BAföG*, the student is ineligible for housing allowance.



Note that this ineligibility only applies if the current financial support already includes some form of housing assistance.

Private ads for flats in Kleve and Kamp-Lintfort can be frequently found on the campus bulletin boards next to the Audimax, canteens and the ZSB. There are also a number of free and popular online portals available in Germany. Some landlords also post available rooms and flats directly through the HSRW website: [Finding a Flat](#).

### **State-subsidised housing (*Wohnberechtigungsschein*)**

State-subsidised housing is available in Germany, but requires a special permit granted by the responsible municipal office. Eligibility depends primarily on income, and permission is granted in the form of an entitlement letter that is valid for up to twelve months. This letter includes the number of people in the student's household and the maximum allowable size of the flat. Student parents are eligible to request a social housing entitlement letter in urgent cases, provided their annual gross income does not exceed a certain maximum threshold.

# 10. Family Fun and Recreation

---

This section provides recommendations on the topic of recreation with children. This list of activities is not exhausted but it serves solely for inspiration. In addition, there are further external offers near Kleve and Kamp-Lintfort that are not listed in this chapter. However, this section might help to get an idea on leisure time activities with children in the surrounding areas.

## **10.1 Kleve**

### **KLEX – Tutorial workshop for children and adults at the HSRW**

KLEX is a German acronym that stands for “**K**indliches **L**ernen **E**rfahren und **EX**perimentieren”, or “children’s learning, experiencing and experimenting”. It was designed to be used by children in a wide variety of applications. The open, unrestricted learning environment offered by KLEX lets students and children learn without disciplinary boundaries: the natural sciences can be combined with theatre and art in new ways, for example, and completely new learning combinations can be invented and tried freely.

Twice a month, KLEX is transformed into an Open Tutorial Workshop where children, teachers and students collaborate in a playful and creative learning environment. These workshops take place during the lecture period on the second and fourth Thursdays of the month, from 10:00 a.m. to noon. This room can also be freely used by students with their children to spend time during class breaks. For booking the room, please contact the below mentioned email address.

### **Tiergarten Kleve e.V.** (in German)

The beautiful animal park in Kleve offers families the chance to see and experience both native and exotic animals up close. Pull-along wagons can be rented for a small fee at the gates and free parking is available out front.

### **Haus Mifgash Kleve**

The non-profit association "Haus der Begegnung - Beth HaMifgash e.V." in Kleve is a non-discriminatory meeting place for people from different cultures and religious communities.

Mifgash House offers weekly [children's yoga](#) for children of the age between 4 and 11.

There is also a [women's café](#) every Thursday from 9.00 am to 12.00 pm. It offers women asylum seekers the opportunity to exchange ideas and offers information and assistance as well as support with visits to the doctor, school, and authorities. Other events such as picnics are also part of the program. Children are very much welcome at the women's café.

### **Outdoor pool Sternbusch – Indoor pool Königsgarten** (in German)

Kleve currently maintains an indoor swimming pool (Königsgarten) for parents and children located not far from campus. A modern outdoor swimming complex (Sternbusch) which opened in 2018 is located in short distance from Kleve.

### **Kleoland** (in German)

For rainy days, birthdays or play groups, Kleoland is a good option for families. The 1,000 m<sup>2</sup> play complex lets kids climb, jump, run and have fun. For younger children, Kleoland also offers a changing station and ball pit.

## **10.2 Kamp-Lintfort**

### **Haus der Familie** (in German)

Haus der Familie (Family House) in Kamp-Lintfort is a Catholic education forum offering a variety of courses and other educational offers for both children and parents. Ranging from athletic activities to cooking courses, Haus der Familie caters to nearly all age groups.

### **Spiel-Dschungel** (in German)

Spiel-Dschungel (play jungle) is an indoor playground open all year for families with children under 12. It is also a good venue for hosting birthday parties in any type of weather or season.

### **Panoramabad Pappelsee** (in German)

*Panoramabad Pappelsee* is a swimming complex in Kamp-Lintfort with indoor and outdoor pools as well as many other fun attractions. Swim courses are offered all year, for example baby aquatics. During open swim hours, the complex is a great place for families to spend the day.

### **Halde Norddeutschland** (in German)

Not far from Kamp-Lintfort, in the town of Neukirchen-Vluyn, visitors will find the *Halde Norddeutschland*, a 102 m artificial rise built on a massive slag heap from the now-decommissioned Niederberg coal mine. Visitors will find a slew of nature trails, viewing points and a full day of hiking possibilities for the whole family.

## **10.3 Around Kleve and Kamp-Lintfort**

### **Irrland**

Full of fun attractions like play barns (for both older and younger children), an indoor climbing world and the largest conservatory on the Lower Rhine; this “all-weather oasis” is sure to entertain kids and parents alike. Families can also bring their own food and barbeque on one of the many grills with adjacent seating areas. Reservations are not required but are highly recommended in the popular summer months.

### **Kernie’s Familienpark Kalkar** (in German)

*Kernie’s Familienpark* in Kalkar is a family fun park with rides, a ferris wheel, trampoline and other attractions for different age groups. French fries, soft drinks and ice cream are included in all ticket prices. The park also offers ample parking at no charge.

### **LVR Archeological Park Xanten & Roman Museum**

This gorgeous archaeological park with Roman Museum in Xanten is like stepping back in time to the Roman colony of Ulpia Traiana, founded on the frontiers of the Roman Empire by decree of Emperor Trajan. However, the park is not just for history buffs: it also offers adventurous playgrounds and picnic areas for families. Entry is free for children under 18 years of age.

Within walking distance of the park visitors will also find Italian restaurant Plaza del Mar, a boat rental area and a minigolf course.

### **Alte Mühle Donsbrüggen** (in German)

The Old Mill Donsbrüggen and the Mill Museum welcome several thousand visitors every year.

Together with their families, children and adults experience an exciting and relaxing day. A varied range of events, guided tours and activity activities invites visitors to experience the world of grain milling even more closely.

### **Embricana** (in German)

The leisure and wellness pool offers a perfect experience for visitors of all ages. The water world features exciting slides and various diving towers for older children.

For the smallest visitors, the indoor area, the 200-m<sup>2</sup> Children's World, has a toddler pool with a ship's canal, gargoyle, and mini slide.

In the outdoor area, the Jungle Pool invites children to splash around and to explore on warm days. Two slides and various waterspouts ensure that the little ones can experience all kinds of fun in the 80-m<sup>2</sup> pool with a depth of 22 cm.

### **Tierpark und Waldlehrpfad Weeze** (in German)

The animal park with forest nature trail and petting zoo and the adjoining nature adventure trail is very popular among families from Weeze and the local region.

Open all year round and accessible free of charge, the animal park in the shade of the trees at the Hertefeld castle ruins is a popular destination for walks and hikes leading along the Jacob Pilgrims' Way or the Nierswanderweg. Visitors have the opportunity to make direct animal contact, whether in the petting zoo with the pygmy goats or at many of the other enclosures. (Almost) all the animals can be fed with the zoo's own animal food. Here in the municipality of Weeze on the Lower Rhine, the enjoyment of peace and idyllic nature is almost absolute.

### **Biotopwildpark Anholter Schweiz**

The *Biotopwildpark Anholter Schweiz* is a wildlife park comprised of 6 kilometers of hiking trails and 50 different animal species that live in a natural compound. The Restaurant *Schweizer Häuschen* was built in 1893 and is idyllically located on an island.

This place was created to relax and enjoy the beauty of nature. Visitors can take time to explore the nature and its local animals.

Group offerings according to age groups can be found on the website. The Biotopwildpark offers regular events, such as falcon shows.

### **Streichelzoo Moers**

The mini-zoo of the city of Moers is small but there is a lot to explore. The pet's corner is located in the centre of the big recreational park near Rodelberg and the soccer fields. Especially for children it promises a lot of fun to see animals from far away countries like alpacas up close and to watch the birds in the aviary.

### **Fingerhutshof Wissel**

The *Fingerhutshof* is a recreational public facility for children and adolescents of the district of Kleve providing self-sufficiency. The farmyard is located in Kalkar-Wissel, directly on the Wisseler See. It encompasses day rooms, barns for sports and games, two kitchens, one soccer field, and a playground for climbing.

The *Fingerhutshof* enables the implementation of youth care measures from 10 participants onwards, such as

- Holiday programs
- Excursions of schools and kindergartens
- Conventions and further training
- Children's parties of institutions and associations
- Events for adolescents
